ROAD CLOSING NOTICE

**KANAWAUKE ROAD (County Road No. 106)
TOWN OF TUXEDO
COUNTY OF ORANGE**

The undersigned Commissioner of Public Works of the County of Orange does hereby close all that portion of Kanawauke Road (County Road No. 106) in the Town of Tuxedo, Orange County, New York. **BEGINNING** at its point of intersection of New York State Route 17/17A and Kanawauke Road (County Road No. 106) and runs **THENCE** in a northeasterly direction along said Kanawauke Road (County Road No. 106) approximately 25,440 feet (4.8) miles to the intersection of Seven Lakes Drive and Kanawauke Road (County Road No. 106) for the purpose of allowing the Orange County Department of Public Works, its agents or contractors, to excavate, repair, pave and do all such work as required in connection with the rehabilitation/replacement of a culvert on said County road, said closing being effective by the conspicuous posting of "Road Closed" signs on or about March 14, 2008.

The said County road will be closed to all through traffic indefinitely in accordance with the provisions of Section 104 of the Highway Law. Appropriate traffic control devices, in accordance with the provisions of the National Manual of Uniform Traffic Control Devices (MUTCD), and the New York State Supplement, will be in place and detour routes will be prominently marked.

Normal through traffic using this portion of Kanawauke Road (County Road No. 106) should use alternate routes or signed detour routing that will utilize Seven Lakes Drive and NYS Route 17.

NOTE TO TOWN SUPERINTENDENT: If the road being closed is a Town Road, the County will erect the necessary signs, barricades, etc. This does not relieve the Town Superintendent of his responsibility under Section 104 of the Highway Law to assure that such signs and barricades have been erected and maintained.

Detour Directions for Kanawauke Road (County Road No. 106):

Traveling Northeast on Kanawauke Road (County Road No. 106):

1. At the intersection of NYS Route 17A/NYS Route 17/County Road No. 106 proceed south onto NYS Route 17 for approximately 4.5 miles to the intersection of NY State Route 17 and Seven Lakes Drive.
2. Turn left onto Seven Lakes Drive and proceed approximately 7.0 miles to the intersection of Kanawauke Road (County Road No. 106) and Seven Lakes Drive (Kanawauke Circle).

(End of Detour)

Traveling Southwest on Kanawauke Road (County Road No. 106):

1. At the Kanawauke Circle proceed south to Seven Lakes Drive for approximately 7.0 miles to the intersection of Seven Lakes Drive and NYS Route 17.
2. Turn right onto NYS Route 17 and proceed approximately 4.5 miles to the intersection of NYS Route 17, NYS Route 17A and Kanawauke Road (County Road No. 106).
